

Tariff Schedule for Retail Tariff Rates of Supply for FY 2018-19

(Effective From 1st April 2018)

LOW TENSION INDUSTRIAL SERVICE

1. Low Tension Industrial Service (LTIS-I) - Demand based

All those consumers opting for LTIS-I category with contract demand upto KW shall be required to pay at the rates indicated below:

1	Contract demand upto 19 KW	Rs. 160/kW or part thereof per month	All units (kVAh)	605

2. Low Tension Industrial Service (LTIS-II) - Demand based

All those consumers under LTS-II category with 3 phase supply and with contract demand above 19kW and upto 74 Kw shall be required to pay at the rates indicated below:

1	Contract demand upto 19 KW	Rs. 200/kW or part thereof per month	All units (kVAh)	605

HIGH TENSION SUPPLY

1. High Tension Supply (HTS-I) - 11 kV

Applicable for supply of electricity for use in installation with a minimum contract demand of 50kVA and maximum contract demand of 1500 kVA.

Character of service: AC, 50 cycles, 3 phase at 11 kV.

TARIFF RATES

Demand charge Rs./kVA/Month of billing demand	Energy charges (Paise/kVAh)
300	All units- 620
The billing demand shall be the maximum demand recorded during the month or 85% of the contract demand whichever is higher. If in any month the recorded maximum demand exceed 110% of contract demand, that portion of the demand in excess of the contract demand will be billed at twice the normal charge.	

2. High Tension Supply (HTS-II) - 33 kV

This is application for use in installations with a minimum contract demand of 1000kVA and maximum contract demand of 15,000kVA.

Character of service: AC, 50 cycles, 3phase at 33Kv.

TARIFF RATES

Demand charge Rs./Kva/Month of billing demand	Energy charges (Paise/kVAh)
300	All units- 615
The billing demand shall be the maximum demand recorded during the month or 85% of the contract demand whichever is higher. If in any month the recorded maximum demand exceeds 110% of contract demand, that portion of the demand in excess of the contract demand will be billed at twice the normal charge.	

3. High Tension Supply (HTS-III) -

This is applicable for installations with a minimum contract demand of 7.5MVA. Character of service: AC, 50 cycles, 3 phase at 132Kv

TARIFF RATE

Demand charge Rs./Kva/Month of billing demand	Energy charges (Paise/kVAh)
300	All units- 610
The billing demand shall be the maximum demand recorded during the month or 85% of the contract demand whichever is higher. If in any month the recorded maximum demand exceeds 110% of contract demand, that portion of the demand in excess of the contract demand will be billed at twice the normal charge.
